# HOS: The **4** Key Revisions

- 1** On-duty limits for **short-haul operations** will increase from 12 to 14 hours and from 100 air-miles to 150.
- 2** The **sleeper berth rules** will now allow drivers to split their required 10 hours off duty into two periods: an **8/2 split**, or a **7/3 split** — with neither period counting against the driver's 14 hour driving window.
- 3** The **adverse driving provision** will extend the driving window **two hours** if the driver encounters adverse driving conditions.
- 4** The **30-minute break provision** will be modified to require the break after **eight hours of consecutive driving time** (instead of on-duty time) and allows an on-duty/not driving period to qualify as the required break.
